1. Introduction

Meghan Rae Music (“I”, “me”, or “my”) is committed to protecting and respecting your privacy. This Privacy Policy explains how personal data is collected, used, stored and protected when you engage my wedding and events singing services. By enquiring about or booking my services, you acknowledge and agree to the practices described in this Privacy Policy.

2. Personal Data Collected

I may collect and process the following personal data when you contact me or book my services:

- Full name(s)
 - Telephone number(s)
 - Email address(es)
 - Home address(es)
 - Wedding or event venue address(es)
 - Wedding or event date(s)

3. Purpose of Data Processing

Your personal data is collected and used for the following purposes:

- To respond to enquiries and communicate with you regarding your booking
 - To issue contracts, invoices and booking confirmations
 - To manage scheduling, logistics and travel arrangements
 - To provide the agreed services at your wedding or event
 - Personal data will only be used where it is necessary to fulfil a contractual obligation or where you have provided consent.

4. Data Storage and Retention

All personal data is stored securely on password-protected systems and handled in accordance with applicable data protection laws.

Your information will be retained for up to five (5) years following your event for accounting, legal and tax purposes. After this period, data will be securely deleted.

5. Data Sharing

Your personal data will never be sold or shared for marketing purposes. Data may only be shared where necessary:

- With other suppliers involved in your event and only with your consent
 - To comply with legal, regulatory, or tax obligations (for example, if requested by HMRC)

6. Social Media, Photography & Marketing

From time to time, I may wish to share content from weddings or events on my website and social media platforms for promotional purposes.

This may include:

- Photos or videos of my performance
 - Photos or videos of guests interacting at the event in the booked venue
 - References to your first name(s) and/or second name(s)
 - References to your wedding date and/or venue
 - Identifiable images or personal details will only be shared with your prior consent
 - If you do not wish your event to be featured, you must notify me in writing before your event date

7. Your Data Protection Rights

You have the right to:

- Request access to the personal data I hold about you
 - Request correction of inaccurate or incomplete data
 - Request deletion of your personal data where legally permissible
 - Withdraw consent for social media or marketing use at any time
